This Policy describes how we treat user information we collect on <http://www.europaeducations.com> and other offline sources. This Privacy Policy applies to current and former visitors to our website and to our online customers. By visiting and/or using our website, you agree to this Privacy Policy.

Information we collect

- 1.Contact information.** We might collect your **name, email, mobile number, phone number, street, city, state, pincode, recent picture, id proof and ip address.**
- 2.Payment and billing information.** We might collect your billing name, billing address and payment method . We NEVER collect your credit card number or credit card expiry date or other details pertaining to your credit card on our website. Credit card information will be obtained and processed by our online payment partner Razorpay.
- 3.Information you post.** We collect information you post in a public space on our website or on a third-party social media site belonging to www.europaeducations.com
- 4.Other information.** If you use our website, we may collect information about your IP address and the browser you're using. We might look at what site you came from, duration of time spent on our website, pages accessed or what site you visit when you leave us. We might also collect the type of mobile device you are using, or the version of the operating system your computer or device is running.

We collect information in different ways.

- 1.We collect information directly from you.** We collect information directly from you when you register through our application form.We also collect information if you post a comment on our websites ,social media sites or ask us a question through phone or email.
- 2.We collect information from you passively.** We use tracking tools like Google Analytics, Google Webmaster, browser cookies and web beacons for collecting information about your usage of our website.
- 3.We get information about you from third parties.** From social media's such as Facebook,Instagram,google,blogs etc.

- 1.We use information to contact you:** We might use the information you provide to contact you through call/email/ message.
- 2.We use information to respond to your requests or questions.**

- 4.We use information for background verification**
